## Clinical Research Orientation and Training for Emory Staff on NIH-defined Clinical Trials

Training supports the quality of clinical trials, the protection of research participants, and the generalizability of study results. At Emory, orientation and baseline training are required for all staff on clinical research studies that meet the <u>NIH definition</u> (which includes FDA-regulated studies). CME/CEU/Nursing <u>credits</u> are issued for several courses and organizations.

Before participating in any research study, orientation and core course completion will be required. If the core course is not completed, the Emory IRB will remove the staff from the study and impose a hard stop. They will not be allowed to participate until they show a certificate of completion and upload it in Emory RedCap eCREST. Any additional departmental training will be considered supplemental. *See page 2 for requirements at Emory-affiliated sites (AVAMC, CHOA, and Grady).* 

Emory Healthcare (EHC) **credentialing is required for Emory clinical research staff** who have direct contact with subjects in an EHC facility and/or will need access to patient medical records for EHC subjects, including remote staff who need access to patient's medical records. Direct contact is defined as transporting patients, collecting specimens, obtaining vital signs, obtaining measurements, performing ECGs, phlebotomy, etc.). The core course completions and EHC Credentialing are for *Investigators* who are magnet-designated<sup>®</sup>, Clinical Research Nurses, Clinical Research Coordinators, or <u>Other Key Personnel</u> and assigned at <u>Clinical</u> <u>Research Orientation</u>. 4 The CITL CRC (Clinical Research Coordinator) course is for both experienced & non-experienced clinical research nurses, coordinators, and other key personnel functioning in the role of a coordinator. Renewal every 3 years in CITL.

<sup>5</sup> Bloodborne Pathogens (BBP) for Research training is required annually for those working on protocols that involve human bloodborne pathogens (including Grady campus or buildings (e.g., Ponce Clinic). Additional training for biosafety and laboratory may be required from EHSO. The EHSO - Shipping and Transport of Biological Materials and Refrigerants (Dry Ice)" training course is available in CITI.

Statt at a non-Emory or an Emory affiliated site conducting or coordinating on studies that meet the <u>NIH-definition of a clinical trial</u> with an Emory investigator may be subject to additional training at Emory. *Note:* Emory Clinical Research Orientation is not required for non-Emory staff but will be essential to understand how research is conducted at Emory. We will work with your site's Training Manager to address your training needs.
